



■ MANUFACTURE

This Reference Product comes from sites that has received ISO14001 certification.



■ DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over a maximum distance of 780 km by road from our warehouse to the local point of distribution into the market in Europe. Packaging is compliant with European directive 2004/12/EU concerning packaging and packaging waste and french decree 98-638. At their end of life, its recyclability rate is 93 % (in % of the mass of the packaging).



■ INSTALLATION

For the installation of the product, only standard tools are needed.



■ USE

Under normal conditions of use, this product requires no servicing, no maintenance or additional products.

END OF LIFE

The product end-of-life factors are taken into account during the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse.

• Recyclability rate:

Calculated using the method described in technical report IEC/TR 62635, the recyclability rate of the product is estimated at 95 %. This value is based on data collected from a technological channel using industrial procedures. It does not pre-validate the effective use of this channel for end-of-life electrical and electronic products.

Separated into:

- plastic materials (excluding packaging) : 31 %
- metal materials (excluding packaging) : 23 %
- packaging (all types of materials) : 41 %



ENVIRONMENTAL IMPACTS

The evaluation of environmental impacts examines the stages of the Reference Product life cycle: manufacturing, distribution, installation, use and end-of-life. It is representative from products marketed and used in Europe, in compliance with the local current standards.

For each phase, the following modelling elements were taken in account:
