■ DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 257 km by road, 272 km by plane and 3594 km by ship from our warehouse to the local point of distribution into the market all around the world.

END OF LIFE

Product end of life management is integrated into product design by the development teams. The dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse.

• Recyclability rate

Calculated using the method described in the IEC/TR 62635 technical report, the recyclability rate of the product is estimated as 90%. This value is based on data collected from a technological channel using industrial procedures. It does not pre-validate the effective use of this channel for end-of-life electrical and electronic products.
