■ MANUFACTURE

This Reference Product comes from sites that have received ISO14001 certification. The final assembly site is located at Wuxi.



■ DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 1000 km by truck from our warehouse to the local point of distribution into the market in Italy.
