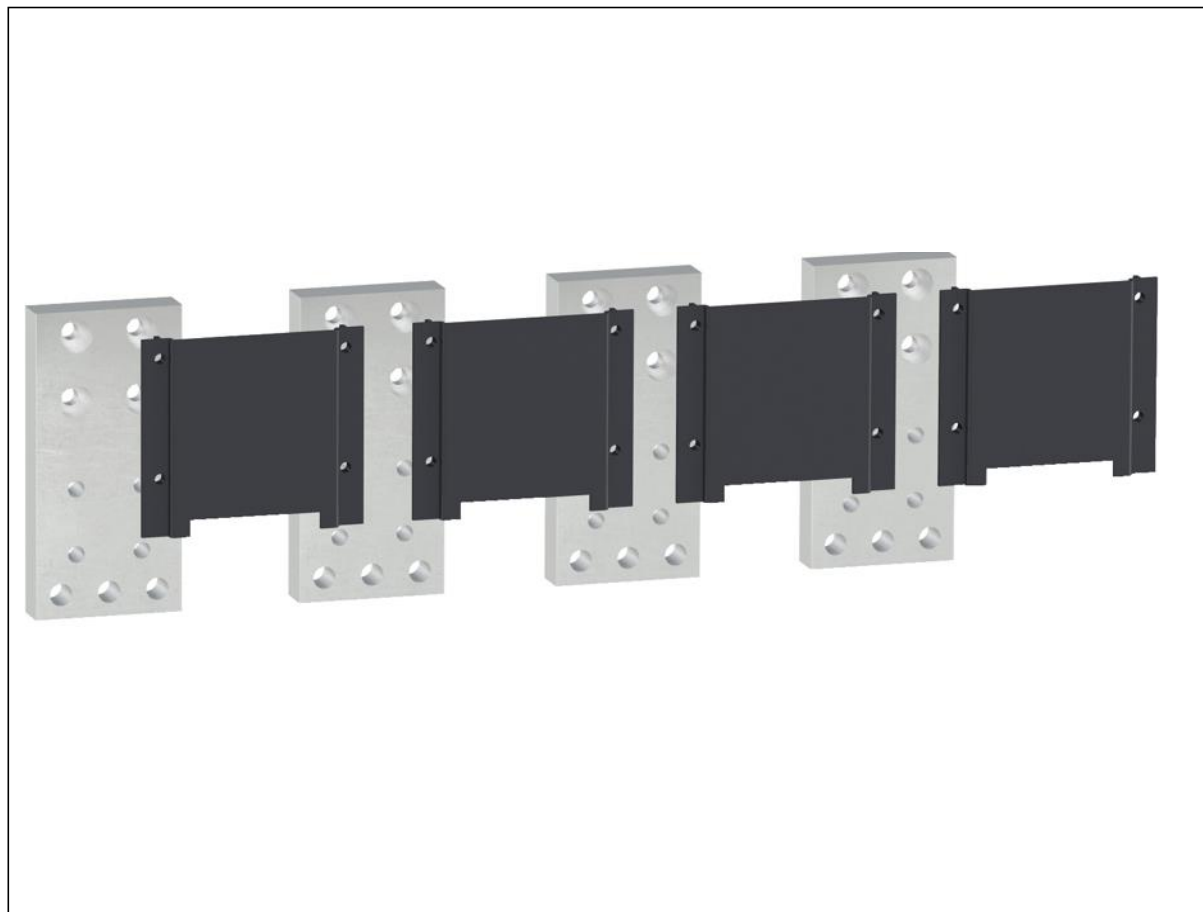

Description of the product	The front bottom connection is used to connect the MTZ2 circuit breaker to the electrical circuit. This type of connector can be used in a fixed or withdrawable configuration. This reference includes 4 aluminium connections and 4 connections screen
Description of the range	The products of the range are: Representative of MasterPacT and ComPacT NS aluminium connections The environmental impacts of this reference product are representative of the impacts of the other products of the range which are developed with a similar technology.
Functional unit	Other switchgear and controlgear solutions mentioned in the scope (e.g. fuses TC32, all-or-nothing relays TC94, Measuring relays and protection equipment TC95), apply the general rules of PCR and mention in the accompanying report the functional unit, the reference product characteristics, the reference lifetime and the use scenario which are applied consistently with the relevant IEC technical standards.
Specifications are:	Protect the installation from overloads and short circuits in a circuit with rated voltage Ue up to 690V AC, rated current In up to 3200A, with 4 poles, a rated breaking capacity Icu up to 100kA rms, and in the Industrial application area, according to the appropriate use scenario, and during the reference service life of the product of 20 years. The specifications mentioned previously will vary depending on the type of circuit breaker (MasterPact MTZ2 range of products) theconnection is connected to. This connection allow a connection between the circuit breaker and the electrical circuit of the installation for 20 years. Nominal current for this analysis is 1250A.
