


Harmony XB5 illuminated modular green pushbutton operates with a spring return mechanism is supplied with 24V AC/DC which uses an integral LED and screw clamp terminals. It is easily installed into standard 22mm diameter panel cut-outs and connected to control circuits with classic screw-clamp connections. It is clearly distinguishable visually at a distance with help of bright and long lasting LED illumination. Product has power consumption of 0.434 W with use rate of 71% with life span of 10 years and product is adhering to standards IEC 60947-5-1 & UL 508.
