
## General information

Description of the product	Portable autonomous intervention luminaire (EN 60598-2-4). Luminaire in which the emergency lighting lamps are energized at all times when normal or emergency lighting is required
Description of the range	Single product
Functional unit	Supply portable lighting to allow servicing in a technical room. This function is provided for ten years by its self-contained power supply.
Specifications are:	The product has a consumption of 0.6W and is designed to operate for 10 years thanks to its IP65 protection rating and IK09 shock resistance. The consumption of the product during its declared lifetime is 52.56 Wh (The usage scenario was considered according to the reference PSR which is a 100% standby mode for 10 years (8760 h/year)).
