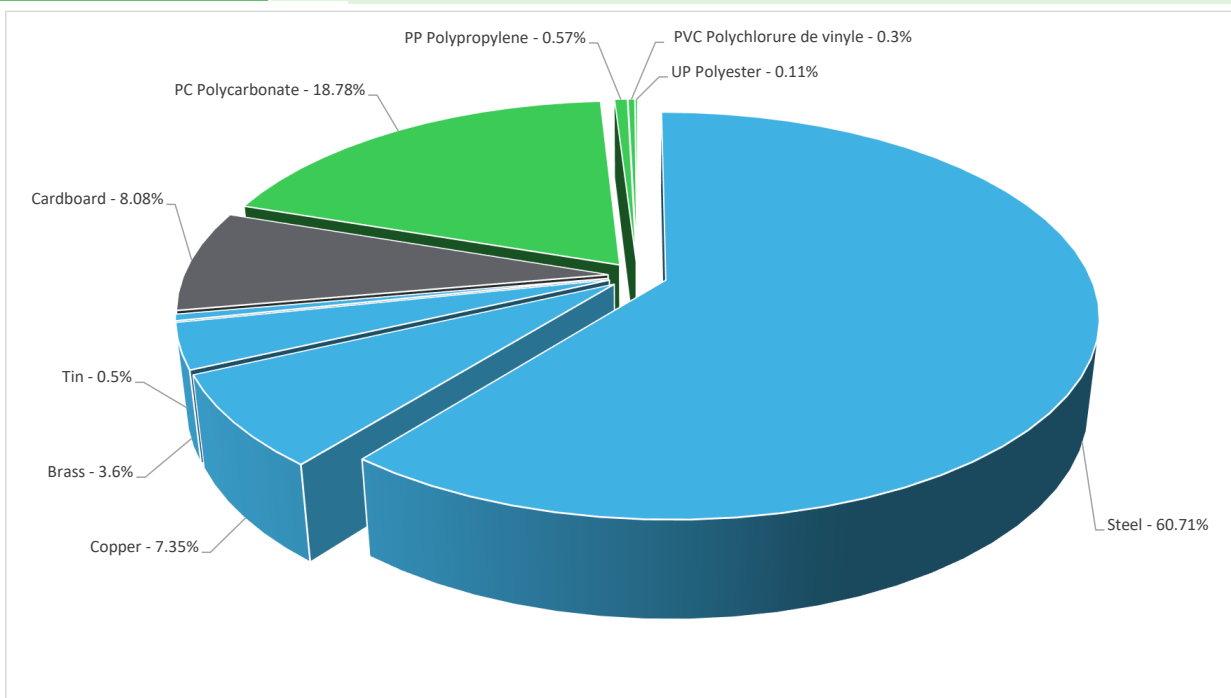
## General information

Description of the product	The METSECT5CC025 is a tropicalised current transformer designed for cable applications. It supports a primary (line) current of 250 A and delivers a secondary current of 5 A. The transformer accommodates cables with an outer diameter up to 21 mm.
