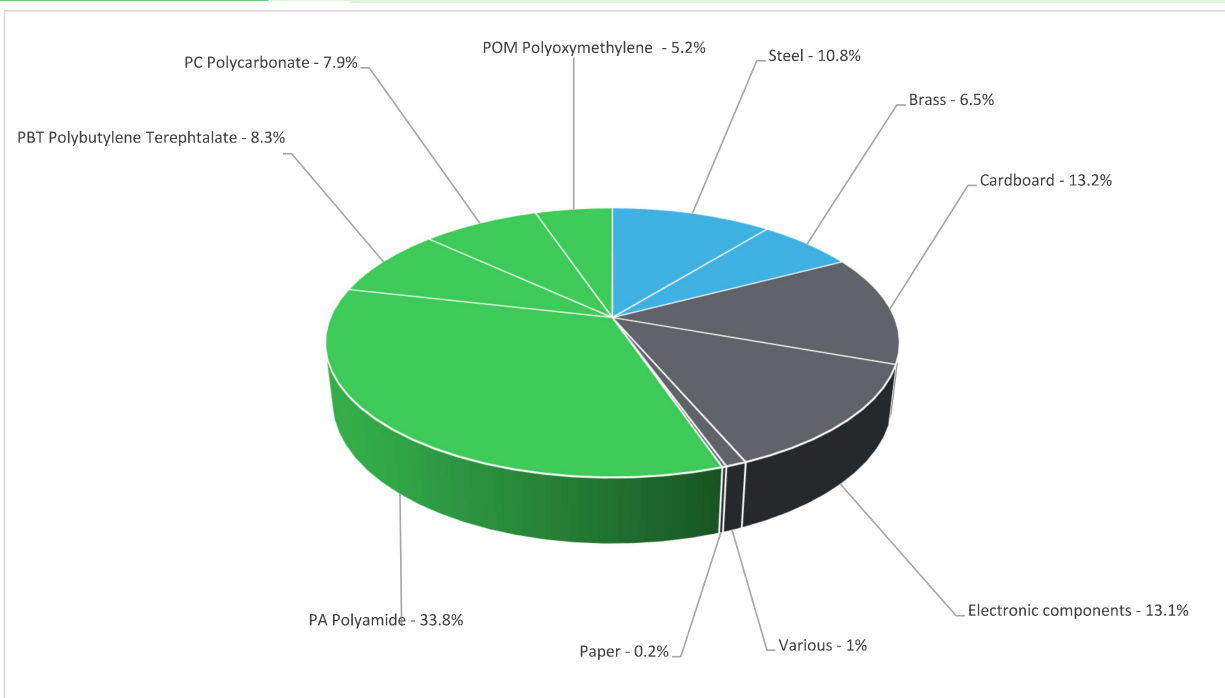


General information

Description of the product	Pilot light is also used for an electrical indicator light that illuminates to show that electrical power is available or that an electrical device is operating.
Functional unit	XB2 monolithic green pilot light comes with integral LED which provides clear visual feedback on the status of machines. Pilot lights helps to know when a machines process has started or stopped to keep workers safe and equipment operating smoothly. Product has power consumption of 3.45W with 71% of use rate during 10 years of life time and adhering with internaional standard IEC 60947-5-1.
