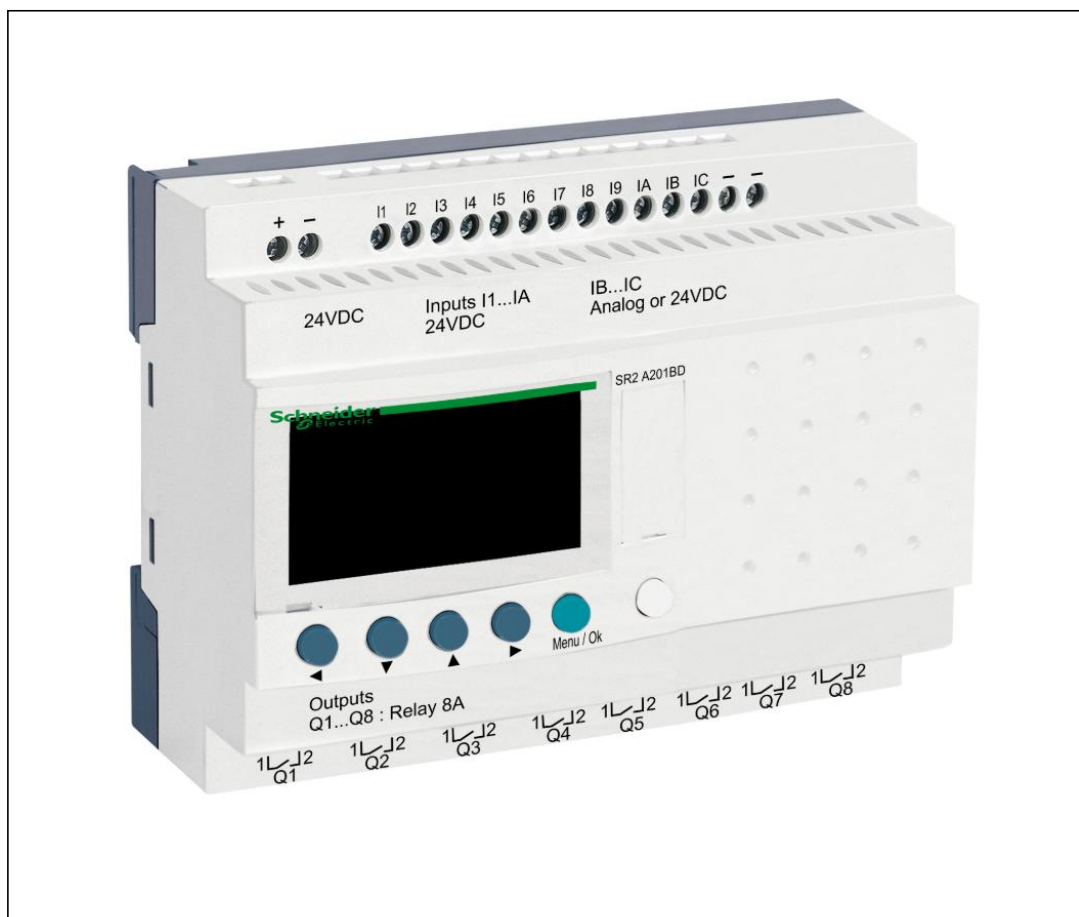

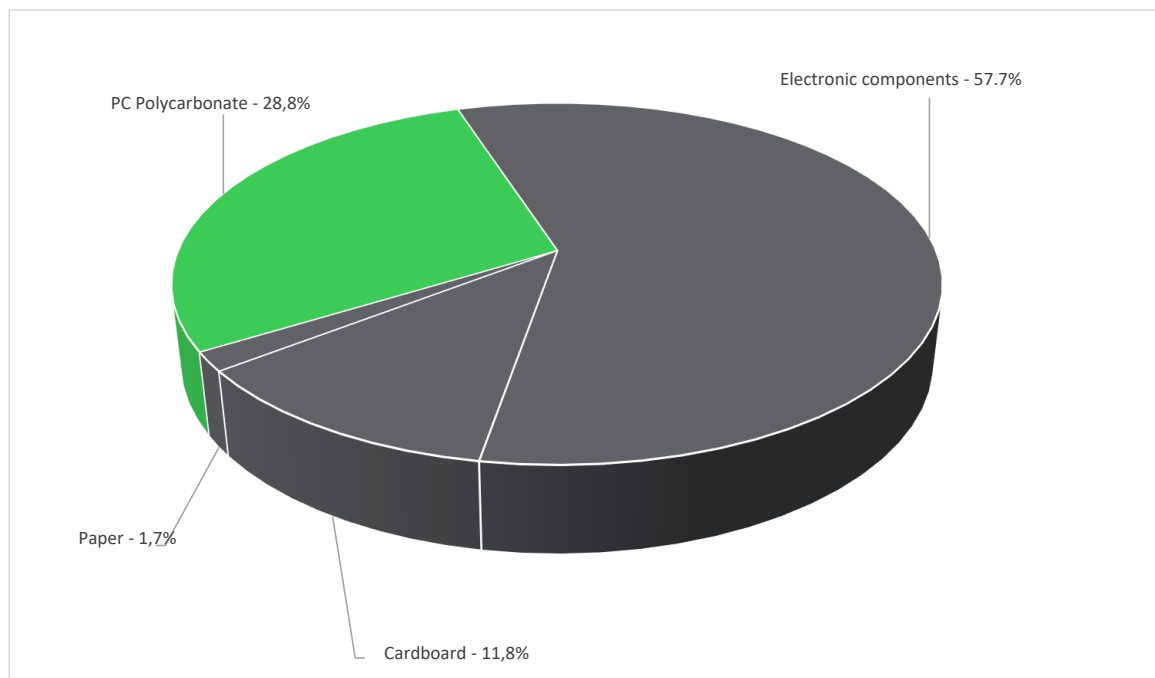
General information

Description of the product	The compact smart relay provides a real alternative to solutions based on cabled logic or specific cards. It comes with display and without clock. Checks program memory on each power up and 0 to 240 with ladder programming number or control scheme lines.
Description of the range	The environmental impacts of this reference product are representative of the impacts of the other products of the range which are developed with a similar technology. This range consists of: compact smart relays with 10, 12 or 20 Inputs / Outputs, with or without a display unit; modular smart relays with 10 or 26 Inputs / Outputs and expansion modules with 4, 6, 10 or 14 Inputs / Outputs, communication expansion modules (Modbus, Ethernet, Modem interface, etc.).
Functional unit	To provide automated control of simple systems from 10 to 40 I/O for 10 years 100% of the time with a power consumption of 6W.
